History of NSCI

The National Safety Council of India [NSCI], set up by the Ministry of Labour & Employment, Govt. of India on 4th March, 1966 is an independent, non-commercial, non-profit making, non-political and autonomous society. It is registered as a society under the Societies Registration Act, 1860 and a Trust under the Bombay Public Trusts Act, 1950. The Management and control of the affairs of NSCI are vested in a multi-partite Board of Governors. NSC has a wide network of over 9,641 members comprising of Corporate, Individual and Life Members, with 12 State Chapters across the country. NSCI serves as a high quality resource Centre for all services on Safety, Fire Safety, Health and Environment including a large variety of information, communication and educational material throughout the country.

The National Safety Council-Kerala Chapter [NSC-KC] was founded in the year 1970 and is governed by an Executive Committee representing Employers, Life, Individual Members, Trade Unions and the Hon'ble Minister of Labour and Skills, Govt. of Kerala as the patron of the Chapter. NSC-KC is registered under the Travancore-Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 during August 2022.
